
## Graduations

I’ve been trying for years to contact her and this brings closure.”

The good news is that she is anxious to get back in the US after 20 years in Hong Kong, and I am happy about that for sure. Anyway, I have a return trip flying back on the first. Talking about heat, it has really been hot and dry here. The corn crops are brown in the fields and only marginally growing to about three feet. Generally speaking, few farms here have irrigation, so the farmers are on TV telling their problems. And

it is sad. Today was predicted to exceed 103 Degrees, so I hope to get to Florida to get some cool.”

**Horace Fite** writes from Pensacola: “Just a note to let you know how much I appreciate receiving the *SPHS Class of 1954 News*. If you cannot put a face together with my name, don’t be surprised. I wouldn’t expect many, if any, of the class to remember me because I was in the unique position of attending SPHS for only the last few months of my senior year. Unfortunately, due to moving frequently in those years I ended up attending 4 high schools in 4 years. Nevertheless, I lay claim to SPHS and thus enjoy hearing about the SPHS Class of 1954 these many years later. Although in the intervening years I continued the habit of moving from time to time, it’s nice to realize that so many of the class remained in and around St. Pete. Now, for me, the adventure of putting down roots in one place or another has worn thin and it looks like Pensacola is finally the place I call home.

If anyone is interested, here’s what has been happening on my end over the past nearly 60 years. Following graduation from SPHS, I moved on to SPJC, then University of Tampa and Stetson Law School. After graduating from Stetson Law in 1962, I was employed as an IRS attorney in Atlanta and worked there for several years. During that time I met my first wife (also a Stetson grad) and in the mid 60’s we transferred to IRS headquarters in DC. Thereafter, we moved again to Atlanta, then some years later back in DC just in time for Watergate, then to Tampa, and finally again to DC where in the early 90’s we ended our years with the government. Over time, my wife had developed expertise in the area of pension law (something I never fully understood) and worked in management both at the IRS and the Department of Labor, while I headed up IRS’s disclosure operations and (later) congressional affairs offices. Unfortunately, a long and relaxing retirement was not in the cards. In the mid 90’s she died of cancer and not wanting to return to the government, I chose Pensacola as a winter home.

Life is never boring, it seems. A few years later in Pensacola I met my second wife, a German lady who earlier had become a U.S. citizen. Since most of her family was in Germany, we acquired a home in Northern Bavaria (Rotherburg von der Tauber) and spent considerable time there while commuting from time to time between Rotherburg and Pensacola.

Sadly, our time together was little more than 8 years. In 2006, she too died of cancer. I still have the place in Germany hoping to return – but illness on my part has curtailed plans. Now, following major surgery last year at M.D. Anderson in Houston, I am able to walk only with the aid of a walker. Since Rotherburg is a cobblestoned 12<sup>th</sup> Century walled town, a walker won't work. Nor, given my incessant medical appointments, would a side trip to St. Pete. So keep the *SPHS News* coming. I'm always interested in seeing what's happening back there."
